___ 1. I understand that participating in the Master Guide Camporee may be a hazardous activity due to the events, and activities.

___ 2. I agree not to participate unless I am medically able and to my ability to safely complete the event or activity.

___ 3. I agree to obey all civil and criminal laws at all times.

___ 4. I assume financial responsibility for any medical expense incurred over and above what is covered by the Texas Conference Association's General Liability Insurance, with competing in the events and activities, including but not limited to falls, contact with other participants, negligent or wanton acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat and/or humidity, all such risks being known and appreciated by me.

___ 5. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency that is over and above what is covered by the Texas Conference Association's General Liability Insurance.

___ 6. Should a claim arise from this camporee it will be governed according to Texas law.

___ 7. I grant permission to the Texas Master Guide Ministry, its affiliates, sponsors, and assigns to use any photographs, motion pictures, recording, any other record of this event for any purpose including but not limited to promoting, advertising and marketing purposes. Any and all photographs, motion pictures, recordings or other records of the event are the sole property of the Texas Master Guide Ministry.

___ 8. I understand that all entries are final with no refunds.

___ 9. The official Camporee director reserves the right in any event of emergency or local or national disaster to cancel the event or change there is no refund of entry fees.

___ 10. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment, and facilities, and cooperative, positive participation. Master Guide Camporee may dismiss, without refund, anyone whose behavior endangers safety or negatively endangers safety or negatively affects a event, a person, a facility, or property of any type or kind.

Waiver & Release of all claims & assumption of risk

I recognize and acknowledge that there are certain risks of physical injury to participants in the Master Guide Camporee, and I voluntarily agree to assume financial responsibility for any medical expense incurred over and above what is covered by the Texas Conference Association's General Liability.

PARTICIPATION WILL BE DENIED, if the signature of an adult participant or parent/guardian and date are not signed before the time and place of the event.

The Master Guide Ministry Is committed to conducting its event and activities in a safe manner and holds the safety of participants in high regard. The Master Guide Ministry continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for the event, programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs. I am solely responsible for determining if I or my minor child is physically fit and/or skilled for the event or activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury, or impairment, to consult a physician before undertaking any physical activity.

Should a claim arise from this event it will be governed according to Texas law.
